

**Official Rules**  
**“Siesta Key and The Hills Giveaway”**  
**Sponsored by MTV**

1. NO PURCHASE NECESSARY TO ENTER OR WIN THE PRIZE. A PURCHASE WILL NOT IMPROVE YOUR CHANCE OF WINNING. AN INSTAGRAM AND/OR TWITTER ACCOUNT AND INTERNET CONNECTION ARE REQUIRED FOR ENTRY. VOID OUTSIDE OF THE FORTY-EIGHT (48) CONTIGUOUS UNITED STATES AND DISTRICT OF COLUMBIA AND WHERE PROHIBITED OR RESTRICTED BY LAW.
  
2. **Entry Period:** The **“Siesta Key and The Hills Giveaway”** (the **“Sweepstakes”**) is a promotion offering participants the opportunity to win prizes by entering one (1) or more individual drawings via Instagram and Twitter. The entry periods (each an **“Entry Period”**) are set forth below. The promotion period commences at 12:00:01 PM Eastern Savings Time (**“EST”**) on May 12, 2021 and ends at 11:59:59 PM (EST) on May 27, 2021 (the **“Promotion Period”**). All entries must be received within one (1) of the following Entry Periods:

3. **Eligibility:** This Sweepstakes is open to individuals who are legal residents of one (1) of the forty-eight (48) contiguous (50) United States or the District of Columbia who are at least twenty-one (21) years of age at the time of entry. Employees and their immediate families (*i.e.*, parents, spouse, children, siblings, grandparents, step parents, step children and step siblings) of Viacom International Inc. ("**VII**" or "**Sponsor**"), Instagram, LLC ("**Instagram**"), Twitter, Inc. There will be twenty (20) winners (each a "**Winner**") selected from the entry pool for Entry Period #1 and ten (10) Winners selected from each of the Entry Period #2 and Entry Period #3 entry pools. Winners will be notified on or around June 4, 2021. Sponsor reserves the right to modify the number of Winners designated for each individual Entry Period in the event that there are not a sufficient number of Eligible Entries. To the extent permitted by law, Sponsor disclaims any liability from, and Entrants, whether or not selected as a Winner, agree to waive, any claims against Sponsor relating to the winner selection or awarding process. If a potential Winner cannot be reached directly during the twenty four (24) hour period in which he/she is being contacted, such potential Winner will be disqualified and an alternate Winner will be selected at random from among the remaining applicable Eligible Entries received. This process will be repeated until a potential Winner responds, as time permits, in Sponsor's sole discretion. The approximate retail value (the "**ARV**") of each Prize is \$125.00 and the total ARV of all prizes to be awarded in this Sweepstakes is \$5000.00 If a Prize is forfeited, and there is sufficient time to determine and notify an alternate winner, the Prize may be awarded to an alternate winner.
